RFP REVISIONS

1. At Page 5 of the RFP – PART 1 – General Information

Insert:

1.6 COVID-19 Vaccination Requirement

This requirement is subject to the COVID-19 Vaccination Policy for Supplier Personnel. Failure to complete and provide the COVID-19 Vaccination Requirement Certification as part of the bid will render the bid non-responsive.

2. At Page 12 of the RFP – PART 5 – Certifications and Additional Information

Insert:

5.3 COVID-19 Vaccination Requirement Certification

In accordance with the COVID-19 Vaccination Policy for Supplier Personnel, all Bidders must provide with their bid, the COVID-19 Vaccination Requirement Certification attached to this bid solicitation, to be given further consideration in this procurement process. This Certification incorporated into the bid solicitation on its closing date is incorporated into, and forms a binding part of any resulting Contract.

QUESTIONS AND ANSWERS

Question 1:

The crew we propose to send will be coming from Nunavut rather than southern Canada. While the RFP does say that we'll be leaving via Trenton we're wondering if there is any flexibility on that requirement because we'd have to travel South only to go back up? There are potential time and cost savings to be had.

Answer 1:

If the Contractor wishes, they may charter their own flight directly from their home base to Eureka, Nunavut rather than Trenton, Ontario. DND personnel will then meet the Contractor's personnel in Eureka, Nunavut. It will be at the discretion of the Bidder to determine which travel option provides the most cost savings and bid accordingly. The financial evaluation will not change regardless of which option is presented.
