AMENDMENT 002

Amendment 002 is to change the closing date of the Request for proposal, to make amendments to Annex A of the Request for proposal and to respond to an inquiry during the solicitation period.

THE INVITATION IS MODIFIED AS FOLLOWS:

1. The end date of the invitation

- a. **DELETE:** **November 8, 2021, 14:00 (EST).**
- b. **INSERT:** **November 10, 2021, 14:00 (EST).**

2. Annex A – Statement of work, 2.2 Tasks, 2.2.2

a. **DELETE:**

2.2.2 The contractor must perform the training at CFB Bagotville during working hours from 7h30 to 16h30 including the breaks (2x 15 minutes) and thirty (30) minutes lunch per day, Monday to Friday. The contractor can return at home during the week-end. The training have to be 120 hours long eight (8) hours per day of teaching minimum and must begin no later than December 1st 2021. The contractor must use the Link-Belt RTC 8050 crane owned by the Transport Unit in locations approved and organized by the appropriate authorities from Transport Unit here in CFB Bagotville.

b. **INSERT:**

2.2.2 The contractor must perform the training at CFB Bagotville during working hours from 7h30 to 16h30 including the breaks (2x 15 minutes) and thirty (30) minutes lunch per day, Monday to Friday. 2.3.4 Fifteen (15) open days after the training, the contractor must give a signed letter which will allow the CFB Bagotville Transport Unit to use the training plan and all teaching content received for all further training within the Wing as determined by the Transport Unit at CFB Bagotville.

b. INSERT:

2.3.3 **Ten (10)** open days after the training, the contractor must give a minimum of one (1) copy of all the teaching documents and training supports (PowerPoint, visual supports, books, exams, etc.) used throughout the training for the CFB Bagotville Transport Unit. This have to include all the training materials which will allow the Transport Unit to train individuals at CFB Bagotville.

2.3.4 **Ten (10)** open days after the training, the contractor must give a signed letter which will allow the CFB Bagotville Transport Unit to use the training plan and all teaching content received for all further training within the Wing as determined by the Transport Unit at CFB Bagotville.

4. Enquiries - Bid Solicitation

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of the enquiries.

Here is the questions which we have received:

Question 1 : Reference: Request for proposal, Part 5, section 5.2.4. We have a trainer who could provide the requested training, but he does not have the Certificate of Approval that you require in section 5.2.4. We don't ask our trainers to have this document. Is a letter from our company certifying that he is employed by us and describing the business sectors of his employment, including crane operation, in which he provides training sufficient? We can also provide his CV.

Answer 1 : **No, the instructor must own the Accreditation of trainers as a crane operator delivered by the Labour Market Partners Commission – Government of Quebec. (<https://www.cpmt.gouv.qc.ca/formation/agrement.asp>).**

Question 2 : Reference: Annex A – Statement of work, point 2.2.2. You ask for the training to start by December 1, 2021 at the latest. We cannot meet this requirement. We could start around mid-January 2022. Can you push the start date of the training?

Answer 2 : **Yes, the training must begin no later than February 23, 2022 instead of December 1, 2021.**
