Amendment 003

This amendment is raised to provide answers to bidder questions received during solicitation period.

A) Questions & Answers:

- Q1.** Which buildings are included?
- A1.** All three buildings on site are included.
- Q2.** When does the Contract start?
- A2.** Work will start immediately once all conditions of the contract are met and a final signed contract document is awarded to the successful bidder. This includes fulfillment of security requirements.
- Q3.** Will you allow proposals from bidders who do not current hold security clearance, or to be eligible for application do they have to have the security clearance in hand first?
- A3.** Bidders are not required to hold clearances to bid. That said, extensive delays awarding a contract would impact site operations and every effort needs to be made to expedite the security review process and find solutions to provide services required immediately upon conditional award of contract. Any delay in the award of a contract to allow the successful Bidder to obtain the required clearance will be at the entire discretion of the Contracting Authority.
- Q4.** How many washrooms stalls are there?
- A4.** 19 individual gender neutral washroom stalls in total between all 3 buildings.
- Q5.** What is the Square Footage of the visitor centre?
- A5.** Square metres:
Interpretive Hall: 754m²
Mechanical Mezzanine – Interpretive: [8m²]
Office: 158m²
Washrooms: 79m²
- Q6.** What is the estimated quantity (EQ) in the contract?
- A6.** **Per month costs for all cleaning (see Annex B - Basis of Payment).** The amount of work may fluctuate between Spring/Summer months and Fall/Winter so we are providing the ability to adjust the monthly cost based on time of year because the hours on site may be different due to cleaning frequency.

ALL OTHER TERMS & CONDITIONS REMAIN UNCHANGED
