Q1. Do I need to provide a completed COVID-19 Vaccination Requirement Certification Form with my bid?

A1: Yes, all Bidders must provide with their bid, the COVID-19 Vaccination Requirement Certification attached to this bid solicitation (section 1, item 1.1.2), to be given further consideration in this procurement process.

Q2. For item 1.4 Pro Indoor Cycle (Spin Bike), the bike we are planning on bidding adjusts for rider size by extending the handlebar post and moving the handlebars forward – the total bike length changes depending on the setup for the rider. At it's shortest, it just meets the 47" limit, but at its longest it is 51". Will you allow a max length of 51" for the bike?

A2: Yes, see amendment to Annex "A", Appendix 1 and Annex "A1" below.

Q3. For item 1.4 the Pro Indoor Cycle (Spin Bike), can you clarify the needed height and how to measure that?

A3: We will remove the maximum height for this item. See amendment to Annex "A", Appendix 1 and Annex "A1" below.

Q4. Will you accept a treadmill that weighs 457 lbs?

A4: No, treadmill cannot exceed weight requirements of Annex "A", Appendix 1.

Q5. Will you accept a treadmill that is 37" wide?

A5: No, due to space restrictions on site, we cannot adjust width requirements for the treadmill.

Q6. For item 1.3.4: will you accept an upright bike that is 21" wide?

A6: Yes, see amendment to Annex "A", Appendix 1 and Annex "A1" below.

Q7. For item 1.3.5: will you accept up upright bike that is 59" tall?

A7: No.

Q8. For item 1.4.4: will you accept a pro indoor cycle (spin cycle) that is 50" long?

A8: No, due to space restrictions on site, we cannot adjust length requirements for the pro indoor cycle (spin cycle).

Q9. Will you accept a partial quote if there is an item that we do not have?

A9: No, only one contract will be awarded from this solicitation and the successful supplier must provide all items described in Annex "A".

Q10. Will you change the requirement for item 1.2 Body Arc Trainer to "elliptical" so that more suppliers can bid?

A10: Yes, see amendment to Annex "A", Appendix 1 and Annex "A1" below.

Q11. Will these 6 pieces be installed in a building located in 2519 Provo Wallis Street or inside the HMCS Charlottetown vessel?

A11: They will be installed on the ship.

Q12. Do we have to include installation charges?

A12: Yes, bid prices must be inclusive of all delivery and installation charges.

Q13. Annex "A" item 4.4.1 says installation must be completed by September 5, 2021, but sections 6.4.2 states the delivery date is on or before March 31, 2022. Please confirm that everything must be delivered and completed on or before March 31, 2022.

A13: The correct delivery requirement is on or before March 31, 2022. See amendment to Annex "A" item 4.4.1 below.

Fitness Equipment Specifications

This document sets out the specifications for the requirements of the fitness equipment. Deviation from this list must not occur without the concurrence of the Technical Authority.

- 1.1.7. Height must be at least 59";
- 1.1.8. Weight must not exceed 400lbs;
- 1.1.9. Maximum user weight must be at least 380 lbs; and
