1. Provide clarification and answers to questions from potential suppliers.

**QUESTIONS AND ANSWERS:**

Question 1	What is the consequence of not being able to provide 20 months dating?
Answer 1	The Department of National Defence requires a minimum shelf-life of 20 months at the time of delivery in order to sustain its strategic medical countermeasure stockpile. The stockpile will be lifecycle managed in accordance with a products shelf-life whereby expiring product will be replaced with newly manufactured material.
Question 2	Please provide clarity around the quantities since it's significantly higher than what the National Defence has been ordering in the past.
Answer 2	The Department of National Defence has recently completed a review and validation of its Chemical, Biological, Radiological and Nuclear (CBRN) medical countermeasure requirements to align with the current Government of Canada Defence Policy. This has resulted in an increase for certain products.
