Question 2: Given that several large, multi-resource RFPs that were on hold pending the outcome of the Federal Election were all posted and open for bidding around the same time, we respectfully request a 2-week extension to the due date for the above-referenced RFP (G9292-248326/A) in order to provide sufficient time to complete submission of the active multi-resource RFPs and to allow vendors to recruit and put together a thorough and complete bid.

Answer 2: The solicitation closing date has been extended by one week to November 30, 2021.
