Q.1 Who is the fire alarm service provider for this building? (example Troy life safety, Cantec, Viking Fire Protection etc.)

R.1 *Fire alarm system is serviced by Troy Life Safety and monitored by Telus Communications (formerly Prices Alarms).*

Q.2 What brand is the existing fire alarm system?

R.2 *Simplex 4100 ES.*

Q.3 Please confirm if all distribution equipment downstream of the new switchboard UU required to be series rated?

R.3 *Due to existing equipment in UE, UA and the other downstream panels being a mix of three different vendors, series ratings between existing and new breakers cannot be achieved, however series ratings between the new equipment is achievable.*

- 1.** *Series rating between new 800A breaker in CDP 'EA' and new breakers in Panel 'UU' is required to ensure fault currents to existing panels UE and UA are limited to <10kA*
- 2.** *UPS shall be rated to 50kA.*
- 3.** *Contractor shall ensure that UPS does not affect series rating of upstream and downstream panel breakers.*
