**Questions and Answers**

Question 1: Does the COVID-19 Vaccination Policy for Supplier Personnel apply to outdoor workplaces?  
Response 1: Yes. Since supplier personnel will be accessing federal government owned or operated outdoor workplaces where they may come into contact with public servants in order to perform work pursuant to a contract with the Government of Canada, then the vaccination requirements of this Policy apply. There is no difference in the requirements of this Policy for indoor and outdoor workplaces.

**COVID-19 Vaccination Requirement and Certification**
