1) Questions and answers

Question 1: To demonstrate compliance with the second mandatory technical criterion (MT2), the instructions require a summary of projects for the proposed resources, and item d. requests contact information for the client organizations, including the name of a contact person. In situations where a resource worked under a firm providing services to an outside client, the outside client is not aware of the specific resources who did the work. As such, while we can provide references for the firm, any reference would not necessarily be able to speak specifically to an individual resource's experience. In past solicitations, RFPs have asked for references for the firm where the resources provided services and/or permitted bidders to use the individual's supervisor as a reference for the resource. Please clarify if either or both of these options could be acceptable.

Answer 1: Please provide contact information for the client organization, including the name of a contact person from that organization, as requested. If that person cannot speak specifically about the work of individual resources, he or she must be able to give references for the firm where the resources provided services. There is no need to add the individual resources' supervisor.
