AMENDMENT 005

This amendment is raised to answer questions and to make the following changes to the RFP:

- Add the COVID-19 requirements and the COVID-19 Vaccination Requirement Certification form and
- Add the Security Classification Guide to Annex D (Security Requirement Check List (SRCL))

1. Questions and Answers:

Q14	SRE 1 General, item 1.2 i). There is an "Error! Reference source not found" message where instructions should be.
A14	Delete SRE 1 General, item 1.2 i) and replace with the following: i) The order of the Proposal should follow the order established in the Submission Requirements and evaluation (SRE) section.
Q15	SRE 1 General, item 1.4 "The ePost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation." Is it permissible for bidders to submit multiple messages with their final proposal documents, in the case that they exceed ePost Connect's messaging size limit of 1GB per single message?
A15	Yes, as long as all the documents belong to the same proposal. Please refer to PI13 for proposal submission instructions and contact Bid Receiving when transmitting documents
Q16	PI5 Integrity Provisions, Proposal, item 5 Confirming with Canada that if a Proponent, its affiliates and its proposed first tier sub-consultants have no charges, convictions or other circumstances listed in the Policy, the proponent is not required to complete and submit an Integrity Declaration Form.
A16	Correct. Please use the Ineligibility and Suspension Policy website link to access " <i>Information to be provided when bidding, contracting or entering into a real property agreement</i> "
Q17	SRE 3.2.1. - Performance-based building Project Sample The design and construction industry is in the early stages of a trend towards net-zero energy and net-zero carbon. The number of built projects that fulfill both of these requirements is relatively small. Some of those projects are small in scale as clients gain confidence in the feasibility of net-zero ambitions. By requesting projects of at least \$50M and up to \$90M, Canada's expectations of the marketplace appear to be out of alignment. We respectfully request that the rated requirements scale for the Performance-based Project be adjusted to award points for projects with values of at least \$20M. The threshold for maximum points should also consider a smaller value.
A17	Please refer to Amendment 004.
Q18	Appendix H, item 7.3 explains that Canada will be retaining a geotechnical and environmental engineering firm. If this is carried by Canada, what scope is the Proponent expected to carry in terms of environmental engineering services? For clarity, can this role be removed from the Price Proposal form?
A18	The geotechnical and environmental engineering firm currently engaged by Canada is conducting the baseline analysis of existing conditions. If required, they will be available to coordinate in order to answer questions on the reports they produced. This role cannot be removed from the Price Proposal form since the successful proponent could be required to implement and reflect the results of the aforementioned report in the overall design.
Q19	Industrial Hygiene Specialist – is this required to be carried by the Proponent? For clarity, can this role be removed from the Price Proposal form?
A19	The Industrial Hygiene Specialist is required to be carried by the Proponent in order to complete the Laboratory Ventilation Assessment (LVA). PWGSC has begun the data collection process of the LVA however the successful proponent will be required to complete the LVA process and apply the results to the overall design.
Q20	If we wanted to bring a specialist who is not listed, can we modify the Price Proposal Form to include additional roles?
A20	Please refer to Appendix C- Price proposal form indicating: Proponents shall not alter this form. A question can be submitted if the proponent considers that additional roles are needed for this project.
Q21	In Amendment 002, Q5, Canada is asking for a New-Brunswick-licensed land surveyor. The project is in Ontario and per Article 7.3, this consultant is carried by PWGSC. Other Consultants for heritage and stone are also discussed in that response, but these do not seem relevant to this project, which has no stated heritage element. The French version of Table B appears to be taken from a different type of project.

Implementation via construction management, or design-build, or public-private-partnership, or engineer-procure-construct project delivery model". Would PWGSC consider accepting projects that have been implemented via a Design-Bid-Build model?
A23	PWGSC will accept projects that have been implemented via a Design-Bid-Build model.
Q24	Commercial Kitchen Design Specialist In the Functional Programming Report, there are few references to food services (only reference to some small pantry areas at 19sm and a support space at 15sm). Can Canada please provide more detailed programmatic requirements and deliverables so that we can accurately allocate a fee for this scope of services?
A24	Please refer to table 4-11 of the Functional Programming Report for a summary of all proposed food service areas. The food service areas are to be kitchenettes which includes sink(s), refrigerator(s), microwave(s), coffee maker(s), counterspace and casework. The food service areas will not be full kitchens nor will they support a third party food vendor. Appendix C – Table B : The Discipline Commercial Kitchen Design Specialist is removed as well as the Category of Resources / Level : Senior Commercial Kitchen Design Specialist and Intermediate Commercial Kitchen Design Specialist.
Q25	Please confirm that bidder questions do not also need to be submitted through ePost Connect.
