QUESTION AND ANSWER

Question 21

The TA qualifications associated with the RFP are far in excess of the current iteration of this RFP and will serve to eliminate the vast majority of skilled/experienced GCDOCS consultants from qualifying to work on any subsequent contract. Specifically:

- The Application/Software Architect requires no less than three (3) certifications from a list of four (4) possible ones, where three of the four are specific to OpenText Content Server.
- The Programmer Analyst requires an OpenText Content Server Developer Certification – a very rare certification amongst the NCR consulting pool.
- The IM Architect requires OpenText Content Server Administrator Certification, which is a technical certification out of character with the requirements of the role, not to mention very rare in the NCR consultant pool
- The Data Conversion Specialist requires one of two Open Text specific certifications, neither of which are commonplace and/or required to fulfil the role.
- The Technical Architect role requires one (1) of three (3) possible certifications, two of which are specific to Open Text and one that is specific to Cloud computing. Again, the occurrence of any of these certifications is rare enough, let alone something that Technical Architects suited for GCDOCS work would possess.

The net effect of the addition of these certifications to the TA grids will be to effectively reduce the potential candidate pool to a handful of consultants, drastically limiting the ability of any supplier to satisfy the needs of the contract. It is also understood that the vast majority of resources on the current iteration of this contract as well as on other GCDOCS contracts throughout the NCR would not satisfy the certification requirements. Availability of qualified resources affects rates, and with such demanding requirements one of two things will happen:

1. The financial structure imposed by a -20% median range with a 40% weighting on Financial score means that rates will not be bid that can secure any viable candidates, despite the challenge of the grids.
2. Rates will need to be so high to secure very rare skillsets from an already limited candidate pool that the Crown will not receive fair value for its investment.

As a result, we request that all Certification requirements associated with the roles noted above be removed from the Mandatory requirements in the Task Authorization grids, and in keeping with the previous RFP have them structured so that they can be requested as additional requirements at the time of callup, rather than being mandatory for the affected grids.
