Response(s) (R) to Question(s) (Q)1:

Regarding Annex "A" Statement of Work, section "Location of Work and Travel" (page 32-33):

Q1

If a second training location no more than 3 hours away by car from the primary location is required, can this travel occur on the same day as training, resulting in an 8-hour training day (7.5 hours of training and 0.5 hours for lunch) plus up to 3 hours travel?

R1

Yes, resulting in an 8 hour training day plus up to 3 hours travel.

Q2

If a second training location no more than 3 hours away by car from the primary location is required, can this travel occur on the same day as participants' travel between their city of origin and the primary training location (i.e. Winnipeg or Edmonton)?

R2

Environment and Climate Change Canada will not allow this added travel to take place during their day of travel from their city of origin to the primary training location.

Q3

If a second training location no more than 3 hours away by car from the primary location is required, can this travel occur on the participants' day off?

R3

No, travel should occur in the participants' day off.
