**QUESTION 03**

During the presentation, it was noted that field data collection is in scope. Please clarify.

**RESPONSE 03**

*It will be the successful proponent's responsibility to manage and oversee all field data collection. It will also be the successful proponent's responsibility to perform all field data collection with the exception of any field data collection that is performed by CBM.*

**QUESTION 04**

How many proponents will advance to Stage 2?

**RESPONSE 04**

*Only one, the Highest Ranked Technical Proponent. If Stage Two negotiations fail, as per the General Instructions, Canada may invite the next highest technically rated proponent to participate in Stage Two.*

**QUESTION 05**

Who are the evaluation board representatives?

**RESPONSE 05**

*The evaluation board members include federal public servants as well as Indigenous partner representatives.*

**QUESTION 06**

This is a conditional PSAB. How does that work?

**RESPONSE 06**

*This procurement opportunity is conditionally reserved for bidding among Aboriginal businesses. This means that if two or more Aboriginal businesses are deemed qualified (receive minimum of 60% in each of the Part A evaluation criteria) then those will be the only bids considered. Otherwise, all bids will be considered and evaluated based on the Part A evaluation criteria.*
