AMENDMENT NO. 005

This amendment is raised to answer bidders' questions.

QUESTIONS AND ANSWERS

Question 7: For Corporate requirement for MTC3. The global pandemic has required resources to take personal time to support their families more than normal. We respectfully request the following changes to this requirement-provide demonstration of resources to support 2 in the last 3 years.

Answer 7: Yes, we will accept 2 full time resources as opposed to 4 full time resources.

Question 8: For Bidder's Corporate RTC1, please confirm whether bidders must demonstrate *total billed value and not total billable value* for providing SAP professional service resources for requirements within the last five years from bid closing date.

Answer 8: Yes, we will change to total billed value for clarity

Question 9: For RTC30, under Project Manager would ESDC also accept a Bachelor Degree in Commerce as students are exposed to general business principles, taking courses in accounting, finance, economics, business management, human resources and marketing and as such would gain similar expertise as a CPA?

Answer 9: For RTC30, No, a Bachelor's Degree in Commerce is not equivalent and will not be accepted.

Question 10: For the ERP Functional Analyst, TRM-PSCD, Level 3 resource grid, MTC2 asks for experience *within the last fifteen years as of the bid closing date*. In order to maintain consistency in the mandatory and rated correlation for each grid, we request that ESDC make the following changes to Rated RTC12:

"Each project cited must have a minimum duration of six consecutive months, within the last 10 15 years as of the bid closing date."

Answer 10: No change to this criteria. Points are awarded for more recent experience.
