2. Question and Answer

Question:

In Annex "A", Statement of Work,

Section 7. Helicopter Requirements

7.1 b) One (1) helicopter such as Bell 206L4 or equivalent, with the following minimum specifications:

4) Range (plus 20 min reserve) 555 km (300 nautical miles)
5) External Load (Cargo Hook Limit) 860kg (1900 lbs) minimum

A Bell 206L4 is unable to meet these requirements. However, a AstarB2 does meet these requirements.

Can you please confirm and clarify?

Answer:

We have reviewed and confirmed that the specifications are indeed accurate for a Bell 206L4 or equivalent helicopter. However, as there may be some confusion regarding the reserve requirement, the reference to the 20 minute reserve has been removed. Please review item 1 of this amendment.

All other terms and conditions remain unchanged.
