Amendment 006

This amendment is raised to provide responses to bidder questions and make changes to the payment tables for both Category(ies): 1 and 2 and Category 6.

Note to Bidders: The incorrect GoCUID numbers and details were identified for items #9 and #10 in the original payment table under "Product Category(ies): 1, and 2, Table 1 – Product Table". These should be the "laminated" versions to match the other furniture items identified for these rooms. Changes are reflected in the payment table below.

Additionally, changes to the estimated numbers for other line items have also been updated (#3, #9, #15, #18, #26, and #27).

A. Questions and Answers

- Q1.** For the Category 1B item 13, will PCA also accept a unit that is 12"D (1bSBCXLGA3612HIXXX) or 18"D (3SOPHHXXPM36D18HIXX)?
- A1.** This line item is for a bookshelf for storage in the library space, the 12" (1bSBCXLGA3612HIXXX) will also be acceptable but bidder must supply all nine (9) shelves that are the same depth. The bidder must indicate in their submission for line 13 if they are supplying nine (9) of the 12" or the 15" bookshelf.
- As the 18" depth (3SOPHHXXPM36D18HIXX) is classified as a "storage cabinet" under Category 3, it will not be an acceptable alternative.
- Q2.** For Category 6 item 4, this chair is specific to the manufacturer Haworth, would PCA allow RFSA generic specifications for a tablet and shelf option?
- A2.** Yes, options from other manufacturers that can give a similar product that fits this space will be acceptable. Please see the adjustment included herein to Category 6 Table 1 – Product Table including the removal of the "To Do" wording (English only).
- Q3.** Would PCA be able to provide a copy of the DWG files for drawings in the design document?
- A3.** No alternative files are available aside from the PDF as attached to the solicitation.
- Q4.** We are looking for clarification on Supply Arrangement – GoCUID requirements as we understand the NWT is a Land Claim area and SA's do not apply.
- A4.** The Western Region includes NWT and Nunavut, with the exception of Comprehensive Land Claims Agreement (CLCA) areas. The final delivery location is not located within a CLCA area therefore the SA is applicable.
- Q5.** Will consideration be given for Indigenous Procurement for this tender?
- A5.** This procurement is issued under the "General" stream of the Supply Arrangement.
- Q6.** The bid response requests the Delivery and Installation to be broken out by the three categories. I just want to make sure the Delivery and Installation costs/charges are to be calculated as if these sections may be awarded separately as this means I am not 'bundling' the delivery costs up to Fort Simpson, but treating them as three separate Delivery and Installation costs, which means the Delivery costs are going to be much higher working this out as three separate trips up North vs one trip.
- A6.** Yes, as this requirement could potentially be awarded to multiple suppliers, Delivery and Installation are to be treated as three (3) separate requirements and priced accordingly for evaluation purposes. The firm lot price(s) will be for evaluation purposes, and any changes required for cost decreases to the Delivery or Installation prices due to multiple categories being awarded to a single bidder will be addressed with the successful bidder after evaluation.
