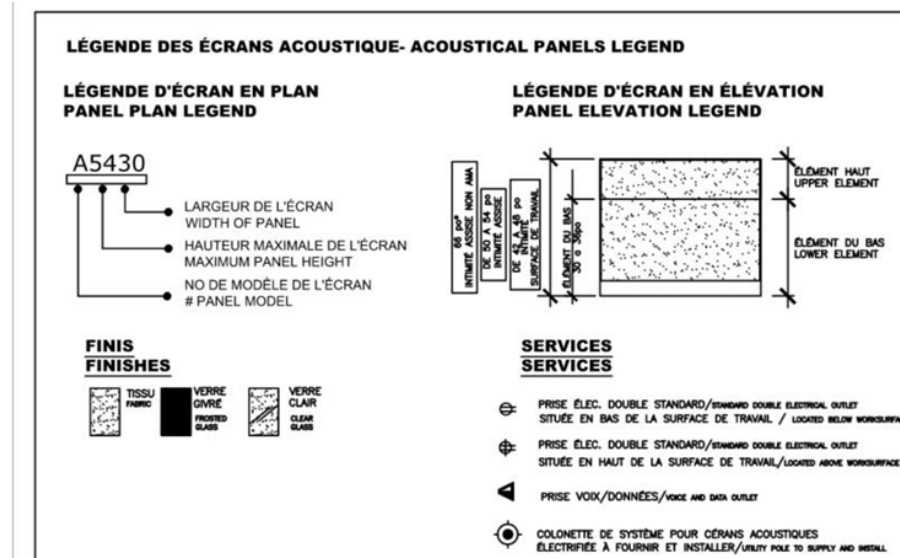

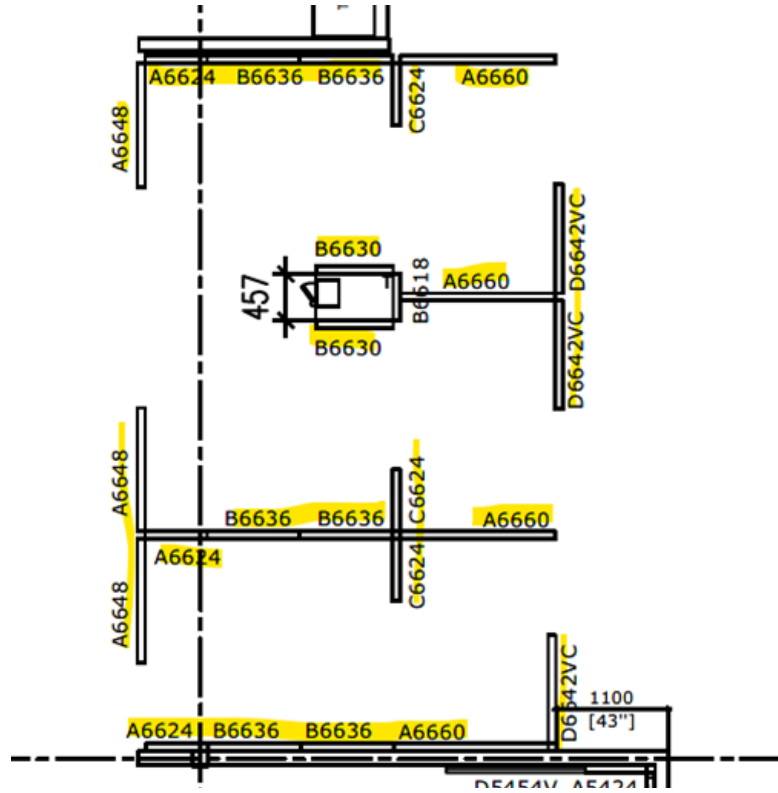
Q1. Can you provide the quantities for the two Cat 1B items?

A1. See amendment of the solicitation document below.

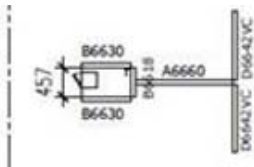
Q2. Can the PSPC send us a legend for the 66 " high panels?

A2. A legend of the panels is already included in the attachment "Plan des écrans".





Q3: For the 66"H x 18"L panels, we can't put a electrical column on the 18' wide panel, we can put it on the side panels the 66 " x 30 " ?



A3. Yes, the column can be on the 66 x 60 panel. The column must be as close as possible.

Q4. Can we replace the segmentation of 2 panels (24"L + 30"L) by a single 54 " Large for economy?

A4. No, we have to respect the customer's standard.

Q5. Can we relocate the outlets behind the towers so that they are more easily accessible?

A5. As indicated in the electrical plan the electrical outlets must be located in the panel adjacent to the tower.

Q6. The usual Citizen Service standard is a small 24 "wide x 42" high return as shown on your legend, however it is listed as 6624 on the plan. Please specify.

A6. After discussion with the customer, we will change the 66 h panels. x 24 width. at the Citizen Service stations for panels of 42 h x 24 width. Total panels = 14
