SOLICITATION AMENDMENT No. 004

This solicitation amendment No. 004 is raised to:

- 1) Publish questions and answers that have been received in relation to this solicitation

- 1) The following Questions and Answers have been provided:

QUESTION 1:

"Can a proponent claim the project experience and propose staff of its parent company, affiliates or subsidiaries when putting forward a proposal?"

ANSWER 1:

No. Experience must come from the Offeror (or, in the case of a joint venture, the persons or entities). Please refer to our the definition of an Offeror in our Standard Instructions 2006 which states that an Offeror is the person or entity submitting an Offer for services and this does not include the parent, subsidiaries or other affiliates of the Offeror, or its subcontractors.

QUESTION 2:

"One of the mandatory criteria categories in each stream (e.g., M1 for Stream 1) asks the Offeror to 'demonstrate that they have a minimum of five (5) years' experience, within the last 10 years, from the date of solicitation closing, performing services in each of the following [...] categories'. Can you please confirm that a) the minimum of 5 years is the total for all categories as opposed to having to demonstrate 5 years of experience in each category; and b) whether the 5 years should be considered as non-overlapping cumulative total of 60 months of work or simply experience performing the work over a 5-year period (i.e., at some point during 5 or more different calendar years)."

ANSWER 2:

- a) The Offeror must demonstrate a minimum of 5 years experience in each category.
- b) The Offeror must demonstrate a cumulation of 5 years of experience in the past 10 years per category. It can overlap and does not need to be consecutive.

QUESTION 3:

"For Stream 3/3A – In section M2, do the projects need to be a Human Health and Ecological Risk Assessment to meet the requirement or can we have a mix of Human Health Risk Assessments and Ecological Risk Assessment covering the 5 years of experience?"

ANSWER 3:

No. Projects submitted need to be a Human Health and Ecological Risk Assessment to meet the requirement.

QUESTION 4:

"For Stream 1/1A – In Section M2/R1 - Project experience. If a project is completed for a federal regulator on behalf of a private company (e.g., an environmental assessment submitted to the Canada Energy Regulator for a pipeline project) would that project be considered a Canadian Federal Government Organization (Canadian Federal Departments, Crown Corporations, Boards, or Agencies)?"

ANSWER 4:

Yes. If a project is completed by a private company to meet the requirements of a federal regulator who will be providing an approval, authorization or permit then yes, the project would be considered federal, however the client would not be federal.
