SOLICITATION AMENDMENT No. 006

This solicitation amendment No. 006 is raised to:

- 1) Publish questions and answers that have been received in relation to this solicitation.

- 1) The following Questions and Answers have been provided:

QUESTION 1:

"6A - Regarding request on lines 8,9, 18,19,20, 24,31, 32 & 40 for daisy chain connectivity - Due to the Government's Health and Safety policies, power bars must be plugged directly into a fixed 120v socket. This would mean daisy chaining is not an allowable application. Please confirm."

ANSWER 1:

These tables are not to be equipped with power bars, they should be completed with recessed integrated outlets for power and data. Linking devices is an allowed application under the SA. Please reference the SA:

.1 Power and Data, unless otherwise specified:

Tables must be provided with concealed cable management and allow for power and data connectivity across the entire multi-table configuration when tables are ganged together.

.2 Training Room Tables

All tables can be supplied with ganging or linking devices to ensure they can be joined together in horizontal positions and/or 90 and/or 180 degrees to each other while still allowing for the provision of power and data connectivity across the entire multi-table configuration.

QUESTION 2:

"6A - Lines 41-43 Could we request further information on the AV equipment supplied by others to help us ensure we can accommodate."

ANSWER 2:

We do not have this information at the moment. Bidders are required to provide a cut-out for the interfaces that are to be installed.

QUESTION 3:

"6B - Line 2 - The GOCUID seems to be incorrect to the description. The GOCUID indicates a Race track shape, description says Rectangular. I believe the correct GOCUID should be 6CNTCHREGLW86064UYXX."

ANSWER 3:

This correction was made through solicitation amendment 004.

QUESTION 4:

"6B - Line 9 - GOCUID seems to be incorrect to the description. GOCUID indicates a training table however description is for a Kitchen Table."

ANSWER 4:

This correction was made through solicitation amendment 004.

QUESTION 5:

"6B - Lines 10, 16-19, 21,22, 25, 26, 29 - Could we request detail on the cable management the client is looking for? This can be quite impactful on cost if manufacturers all interpret differently."

ANSWER 5:

The client is looking for any wiring under the table to be in a tray or protected in some kind of casing, so that it is safe for the users. The interfaces incorporated on the surface, if there's any kind of wiring

involve, would be a retractable system, or a trough that the wire can go into and not hanging out on the surface of the table when not in use.

QUESTION 6:

"6B - Line 15 - Would the client accept a 19"H although calling out 14-18" as the SA spec document indicates allowance of 14 -21" for coffee tables."

ANSWER 6:

No.

QUESTION 7:

"6D - Line 4 - would client accept a different GOCUID with either a) metal legs, or b) wood legs with upholstered seat?"

ANSWER 7:

No; In addition, an upholstered seat is not acceptable.
