Questions and answers

Q1: Within Attachment 2 to Part 4, in section 'RT2 Achievements of Bidder On Projects' in the Point Rated Technical Criteria, RT 2.3, #7 asks the proponent to provide the following: 'Value of the bidder's contract for real property project management services.' Can you please clarify whether the projects put forward under RT2 can include Public Sector Project Management services in lieu of "Real Property Management Services"?

A1: The contract example used for RT 2.3 #7 can be for public sector project management services, as long as it is associated with the delivery of real property project(s).

Q2: Within Attachment 2 to Part 4, under the Mandatory Technical Criteria, MT1 states the following: 'Résumés for optional resources would be requested as required.' Is the proponent required to put forward a certain number of Optional Resource resumes per resource.

A2: All resumés for the balance of required resources would have to be submitted upon contract award. Résumés for optional resources would have to be submitted post contract award, at the time PSPC is seeking to obtain the services of the optional resources.
