3. Is the winning bid able to put Sea Can(s) for supply storage on Garrison property?
4. Will the winning bid have access to the DWAN for email purposes for operational requirements?

5. Will the winning bid have access to the 'N' drive in order to provide and/or maintain specific forms, documents and spreadsheets, to the standard and frequency directed by the P.A.?
