Description of the Requirement:

The objective of this Contract is for one Senior Business Consultant to manage between three and five evaluations conducted within the Office of Audit and Evaluation (not all concurrently and not at the same stage of progress). Each evaluation project will be staffed with an appropriately sized team, depending on the size of the project undertaken (usually between two and five staff members). Evaluations conducted within the Office of Audit and Evaluation are internal; that is, they are conducted by evaluators within the Program Evaluation Division of the Office.

Level of Security Requirement:

1. The contractor must, at all times during the performance of the contract, hold a valid facility security clearance at the level of **secret**, issued by the Contract Security Program (CSP), Public Works and Government Services Canada (PWGSC)
2. The contractor personnel requiring access to **protected/classified** information, assets or sensitive work site(s) must **each** hold a valid personnel security screening at the level of **reliability status or secret** as required, granted or approved by the CSP, PWGSC
3. The contractor **must not** remove any **protected/classified** information from the identified work site(s), and the contractor must ensure that its personnel are made aware of and comply with this restriction

4. Subcontracts which contain security requirements are **not** to be awarded without the prior written permission of the CSP, PWGSC
5. The contractor must comply with the provisions of the:
 1. Security Requirements Check List, attached at Annex C
 2. Contract Security Manual (latest edition)

Proposed period of contract:

The proposed period of contract shall be from date of contract award to August 30, 2022.
