Question 15: We are considering submitting a bid for Translation and Editing Services for the Canada School of Public Service (CSPS-RFP-21NG-0183/A). In MT2, it is stipulated that the resources must have a minimum of three (3) years of experience in delivering translation and/or editing services for federal departments or agencies. Would you also consider translations of provincial public enquiries reports (for example, Ontario's Long-Term Care COVID-19 Commission; Motherisk Report [Ontario Attorney General])? While these are provincial enquiries, they have national/federal implications.
