Solicitation Amendment No. 001 is being issued to address the following items:

A) Question and Answer

A) Question and Answer

Q1: Chair A1 - Will the Client respectfully accept a seat depth range of 18" to 21"?

A1: No. Only an adjustable range of 16.5" to 18.1" is acceptable.

Q2: Chair A1 - Would the client also accept a multi-tilt mechanism or synchro tilt mechanism on this chair?

A2: Both multi-tilt and synchro tilt mechanisms are accepted because they are both independently tilt mechanisms as indicated in the chair builder.

Q3: As a result of recent global supply chain issues, some lead times are longer than the standard 6-10 weeks we can guarantee during calmer times. With that in mind, would a delayed delivery be accepted by the Government of Canada in this particular instance? Or, are you able to advise when the contract will be awarded?

A3: Please advise of dates for delivery and installation. It will be considered in the tender review.

Q4: Would CH-1 (Chair A1) be acceptable to have fully adjustable arms (height, width and depth) that simply do not pivot/ angle adjust? The arms would have appx 2" of width adjustment.

A4: We will deem this option as acceptable.

Q5: Please confirm these chairs will not be stored and there is no need to deliver them in cartons. We would deliver them boxed if they will be going into storage and this is preferred for protection, but would otherwise deliver them fully assembled and blanket wrapped, to make it easier for our crew to complete installation at their final locations if they are going to be used immediately.

A5: Chairs will not be stored. They will need to be assembled and situated on site.
