Q1	Can you verify that Annex forms B and C are what is required to be prequalified?		
A1	Respondents must meet the Mandatory Experience Requirements of Annex B and Mandatory Service Requirements of Annex C. Please refer to Article 4.4 Content of Response for the documentation required in a RFSA submission to this process.		
Q2	Further on the security clearance request, it seems as "Organizations must get sponsored before they can register and begin the screening process. ". Can you sponsor us to get the screening process started with PSPC's CSP?		
A2	Canada confirms it will sponsor any Respondent attempting to obtain a security clearance.		
Q3	Annex K - RFP and Resulting Contract Clauses - Can you please elaborate the purpose of this form? Do we need to fill-it out and submit it? Or does it serve as an example only and no action is required from our end.
