SOLICITATION AMENDMENT No. 006

This solicitation amendment No. 006 is raised to:

- 1) Publish questions and answers that have been received in relation to this solicitation

- 1) The following Questions and Answers have been provided:

QUESTION 1:

"For the Resources (M3 and R5-R7), can the same resource be listed in more than one resource category? For example, can the same person be the Senior Resource – Project Manager and the Senior Resource – Certified Industrial Hygienist or Senior Registered Occupational Hygienist?"

ANSWER 1:

No, key resources must only be used in one category.

QUESTION 2:

"For R3 Capacity Management, can the same resource be listed in more than one category? For example, can a Senior Resource also be a Senior Field Resource and can a CADD/Draftsperson also be either a Junior or Intermediate Resource?"

ANSWER 2:

Yes, if the years of experience specified for the category is met and the experience is relevant to the category. For example, a Senior Resource with 11 years of experience can also be a Senior Field Resource if they also have more than 8 years experience as a Senior Field Resource. A CADD/Draftsperson with 5 years of CADD experience would not be eligible as an Intermediate Resource, unless they also had 5 years experience delivering the services described for the Stream in Appendix 1 to Annex A.

QUESTION 3:

"Would PWGSC be willing to extend the closing date for the solicitation?"

ANSWER 3:

No.

QUESTION 4:

"For Stream 3/3A - In Section R8.2 Senior Resource - Project Manager, can you please confirm that the third option for a project is a Contaminated Sites Remediation or a Sediment Remediation?"

ANSWER 4:

Yes, the third category project must be a contaminated site remediation or a contaminated sediment remediation project.

QUESTION 5:

"Can you please confirm if a screenshot from the Professional Engineers of Ontario website would be acceptable for proof of P.Eng.?"

ANSWER 5:

No, a screenshot is not be acceptable proof. A photocopy of the professional license is acceptable.

QUESTION 6:

"Can you please confirm that the same project can be used for different categories if the description focuses on only the specific scope for the write up? (For example, an HHERA being used for the ERA project and the HHRA project)."

ANSWER 6:

Yes. Note: In such a case as the example, only the cost for the HHRA or ERA portion of the project can be used where Project Value is evaluated for.

QUESTION 7:

"For Stream 1 - Corporate Experience – Would you consider a draft report submission of a Biological Studies project (subcategory Species at Risk) to our client as a completed project?"

ANSWER 7:

No, draft reports are not considered to be a completed project. Projects must be completed for demonstrating experience.

QUESTION 8:

"Can you please confirm that the project start dates can be more than 10 years ago as long as the completion date is within the 10 years from the solicitation closing?"

ANSWER 8:

We are looking for demonstration of recent experience, so while a project start date may be more than 10 years ago, the experience being demonstrated for Corporate Experience on a project must be within the last 10 years.
