#### **QUESTION 1:**

Sampling for bacteria is required for each site as outlined in Section 4.3 of Annex A, "Microbiological analysis will include but will not be limited to the enumeration of e. coli and total coliforms."

Just as clarification would you like the analysis by MPN as opposed to Presence/Absence?

#### **ANSWER 1:**

Correct - MPN.

#### **QUESTION 2:**

In Section 4.3 of Annex A, it is stated that the microbiological "samples must be delivered to the lab within 24 hours of collection." In Newfoundland, due to the nature of the rural sites and the distance and time it takes to get samples back to the lab, the lab allows for 30 hours hold times for samples to be received. Is this something that would be acceptable for this project?

#### **ANSWER 2:**

If the lab allows specimens to be delivered within a 30-hour time window, that is acceptable.

## **QUESTION 3:**

For the sites listed in Appendix A-1 NL EAST there are 5 sites listed for St. Anthony which is located at the top of the northern peninsula of the province, would these sites be able to be included in the NL WEST region to simplify the sampling routes?

In addition, For the sites listed in Appendix A-2 NL WEST there are 5 sites listed for Placentia which are located closer to the NL EAST sites, would these sites be able to be included in the NL EAST region to simplify the sampling routes. This would involve a direct switch of 5 sites from NL EAST to NL WEST and vice versa.

#### **ANSWER 3:**

Yes, it is acceptable to include the 5 sites in St. Anthony to the Western Region and have the 5 sites in Placentia categorized under the NL East Sites.

Appendix A-1 and Appendix A-2 have been updated to reflect these changes.



### **QUESTION 4:**

I'm seeing some differences in between the Appendix A and Annex B in terms of numbers of locations and samples and I just want to confirm the numbers to ensure we are bidding on the correct numbers. The following table outlines for each region the current number, the numbers I'm getting, and the difference (either too many or not enough samples). Can you please clarify the correct numbers for each region?

#### **ANSWER 4:**

Please see Annex B footnote (5) for a breakdown of how these numbers were determined.

### **QUESTION 5:**

In the bid, a link is provided to the PWGSC requirements but states that these may differ from RCMP requirements. Further on it says that RCMP Facility Access Level 2 (Escort Required) is the level of security needed.

Aside from providing a list of people who would be completing the work, and the laboratory we anticipate sending the samples to for analysis, what will we need to do to meet the security requirements for the project?

#### **ANSWER 5:**

Security clearances are not required at time of bid closing but are required before a contract can be awarded. The successful bidder will be provided with instructions how to proceed in obtaining the required RCMP security clearances at that time.
