Question 14:

Regarding M3: The proposed resources must have demonstrated experience in respectively leading (Senior Project Manager) and supporting (Junior Project Manager) the production of plans, charts, tables, and diagrams to assist in analyzing or displaying problems, and executive summary presentation material for senior executives.

To demonstrate experience, the Bidder must also provide a copy of a presentation to senior management (Executive and up) that demonstrate advancement on projects and analysis (charts, graphs, tables) with recommendations.

Due to the nature of high level security capital projects, the materials including classified documents, presentations, briefing notes and business case proposals are classified as Protected Level B or higher. Therefore, Senior Consultants and Project Managers are not allowed to keep or store previous materials from their previous projects as they are proprietary to the respective department.

Can the Crown delete the requirement to provide a 'copy of presentations to senior management' and revise the requirement to "provide an in -depth project description" instead?

Response 14:

PSPC accepts that the requirement to provide a copy of the material can be deleted and replaced by providing an in-depth project description along with the name of the government resources with contact information assigned to the project, the department, the dates, etc. You need to refer to an explicit reference in the bid submission material to support your statement.

Question 15:

Can the Crown extend the submission deadline to Monday, December 20th, 2021 to allow sufficient questions to be answered?
