certification, will be considered for meeting Mandatory Technical Criteria 2, 3 and 4 (MT2, MT3, and MT4) in the Mandatory Technical Criteria section.

Q2: Company XXX understands the intention of awarding three positions on this contract (1.2.3 & 1.2.8). Will PSPC allow the proponents to be on multiple awarded contracts? For example, can a proponent bid both individually to win one contract and also win as part of a joint venture and/or sister company?

A2: Individual members of a joint venture cannot participate in another bid, either by submitting a bid alone or by participating in another joint venture. Please refer to Part 3, section (b) Submission of Only One Bid in the RFP.

Q3: Can PSPC provide a cap on liability? Contractors are unable to gain unlimited liability insurance and as such, are effectively uninsured on that liability. We request that a cap is established regardless of the value so that Contractors can gain insurance.

A3: We cannot put a cap on liability. Please refer to Annexe D, point 1: The Contractor must obtain Commercial General Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence and in the annual aggregate.

Q4: Regarding, 2035 06 (2013-06-27) Subcontracts #3 (ensure obligation outside of our control), we cannot ensure this and believe that this could be an issue for other professional services firms as well. Would PSPC consider revising this to include "use reasonable endeavours to" before "ensure"?

A4: All of the clauses in the General Conditions 2035 for higher complexity services are part of this request for proposal. Your request for revision will be considered, however, the clauses are part of a legal text and will not be changed at this time.

Q5: Clause 2035 09 (2008-05-12) regarding the Time is of Essence clause, would PSPC consider revising this clause to indicate that for the performance of the services pursuant of the agreement, the programme of works shall be agreed between both parties.

A5: All of the clauses in the General Conditions 2035 for higher complexity services are part of this request for proposal. Your request for revision will be considered, however, the clauses are part of a legal text and will not be changed at this time.
