### **Description of Work:**

The RADARSAT Constellation Mission Operating Licence (RCMOL) required under the Remote Sensing Space Systems Act (RSSSA), was issued by Global Affairs Canada (GAC) in 2019 to allow The RADARSAT Constellation Mission (RCM) to be launched and operated. It imposes the obligations and conditions necessary for the protection of national security. Unlike RADARSAT-2, RCM is operated by the Government. Its operation involves multiple government departments and it handles both classified and unclassified SAR and unclassified AIS data.

Operating remote sensing satellites under the RSSSA regime is new for the Canadian Space Agency (CSA) and implies the compliance to many new regulatory obligations and interactions with user departments and operating partners.

The winning bidder will have to support of all tasks related to the management and implementation of the RCMOL, the RSSSA and its associated regulations, for ensuring all compliance by the CSA with the conditions and restrictions imposed by GAC. This support includes all projects and associated services related to the RCMOL implementation in a multi-missions environment.
