This solicitation amendment is raised to:

QUESTIONS AND ANSWERS

- Q1. Zip file includes an Autocad file called Cabot Room, in addition to Sydney Floor Plan. Should we disregard the Cabot Room as Annex C does not seem to show the quantities for that room
- A1. The only information regarding panels is in the file PDF and autocad files "Sydney Floor Plan F&A Suite (with panels). The other floor plans included in the solicitation are for the collaborative furniture portion of the requirement.
- Q2. Annex C - Please confirm the height of panels. PDF drawing notes the height to be 42"H and 53"H, whereas the description notes as base height (34"H for our standard base height). Please provide a floor plan where the base heights are located.
- A2. All panel heights are to be at 42"H except for two add-on panels that will be 53"H. The add-on panels will be applied to the workstation circled in the PDF ("Sydney Floor Plan FA Suite (with panels)") attached in the solicitation posting for this amendment.
- Q3. Annex C - Item 2c notes type of power feed to be base. However, 2D pdf drawing notes as ceiling. Please confirm.
- A3. There is one pac pole providing power from the ceiling.
- Q4. Sydney Floor plan shows receptacle location for specific panels. It looks like not all panels are to be powered. However, Annex C indicates panels are to be 'powered' for all.
- A4. All panels are to be powered.
- Q5. Will the shipping location be able to accommodate a 53 ft trailer? If not, what is the max. truck length the location is able to accommodate?
- A5. A 53' trailer will be too large to maneuver on our site. A 26' box truck or 30' trailer would probably be the maximum we could accommodate.
