- Q1:** Is it possible to suggest two hotel establishments for the same rate to house all the DND personnel for their training session in Temecula? The combination of singles and doubles add up to 88 rooms and between two sister properties, they can all be accommodated.
- A1:** Yes, as long as both hotels meet all of the requirements of the SOW (minimal number of rooms, parking spaces, etc.) and that both hotels meet all of the mandates of the SA and RFP.

- Q2:** Can we bid in US dollars?
- A2:** Yes you can bid in US dollars. For evaluation the bids will be converted to Canadian currency using the Bank of Canada rate for the closing date of the RFP.
