### **Description of the Requirement:**

The objective of this Contract is for one Senior Evaluation Services Consultant to manage between three and five evaluations conducted within the Office of Audit and Evaluation (not all concurrently and not at the same stage). Each evaluation project would be staffed with an appropriately sized team, dependent on the size of the project undertaken (usually between 2-5 staff members). Evaluations conducted within the Office of Audit and Evaluation are internal, that is, conducted by evaluators within the Program Evaluation Division of the Office.

### **Level of Security Requirement:**

- The contractor personnel requiring access to protected/classified information, assets or sensitive work site(s) must each hold a valid personnel security screening at the level of reliability status or secret as required, granted or approved by the CSP, PWGSC
- The contractor must not remove any protected/classified information from the identified work site(s), and the contractor must ensure that its personnel are made aware of and comply with this restriction

- 4. Subcontracts which contain security requirements are **not** to be awarded without the prior written permission of the CSP, PWGSC
- 5. The contractor must comply with the provisions of the:
  - 1. Security Requirements Check List, attached at Annex C
  - 2. Contract Security Manual (latest edition)
