The amendment to the bid solicitation is to address the enquiries received:

Response(s) (R) to Question(s) (Q):

Q2. The Request for Proposal states that "The Contractor's/Offeror's personnel requiring access to **protected** information, assets or sensitive work site(s) must **each** hold a valid **reliability status**, granted or approved by the **CSP/ISS/PSPC**". This indicates that we can include personnel that do not currently have Reliability Status to do certain elements of the project, as long as they do not access protected information.

However the Security Requirements Check List indicates the following "May unscreened personnel be used for portions of the work? No"

Our question is can we include individuals in the proposal that do not currently have Reliability Status as long as they do not access protected information during the study?

R2. The Security Clause requires that all personnel requiring access to protected information and assets must have reliability status. In order to complete the work under the resulting contract, ECCC will provide a laptop and VPN access to the Contractor. Only security cleared individuals will be granted access to both the laptop and VPN.

It is the responsibility of the Contractor to ensure: that their personnel have been briefed on their responsibilities for the handling and safeguarding protected and/or classified information and assets and comply with Chapter 6 and Annex C of the Contract Security Manual.

All other terms and conditions of the Bid Solicitation remain the same.
