For Q&A 1-5 See Solicitation Amendment 001

- Q6. Please supply either a CAD file, or a clearer PDF as some of the electrical and data information is difficult to read. Please ensure it contains the following information:
 - a. Electrical feed locations to connect to base building which will allow for proper electrical specifications resulting in accurate pricing
 - b. Placement location of height adjustable tables
 - c. Lower offices on plan (103/104,?) showing in full
 - d. Confirm panel matrix showing a work surface privacy panel height of 42-49" (see question 7 below for further enquiry) – do I need a new pdf Appendix C for this amendment? I had made the changes in the CAD file. There's only one page of Appendix C that has changed, see attached PDF
- A6: An AutoCad File and an additional floor plan have been uploaded as attachments. Electrical outlets are provided by the General contractor. The workstations get power from below and the panels will have those whips.
- Q7. Please clarify overhead requirement versus panel heights. A worksurface privacy height panel was indicated (42-49"), with this panel height a standard overhead mounted in the locations shown on plan would cover the worksurface mounted at standard height (29") rendering it unusable.
- A7. All worksurface privacy height panels are amended to seated privacy height. See uploaded drawings/floor plans
- Q8. Lines 4-7 appear to pertain to the private office furniture and the following questions are under the assumption they are to be a U-shape for 2 offices:
 - a. Would it be acceptable to submit line 5 as 1BFFHREC (worksurface with C-Legs) to allow for knee space beneath the bridge within a U-shape set up?
 - b. Would it be acceptable to submit line 6 + 7 as 1BFFHREG (worksurface with full gables) to allow for better support of the hutch?
- A8. The response to both Q8a and Q8b is yes.
- Q9. Please confirm Gocuid of line item 8 as it appears to be missing a digit.
- A9. Correct, GoCUID should be 1bSBBMCAA1524XXXKXX



- Q10. Item 10 is for a 72" hutch (qty of 2). Please confirm location of second hutch as there is only a single freestanding desk of matching size specified to mount onto, and only a single hutch shown on plan.
- A10. There is one (1) 72" hutch located in 105D along left wall. Solicitation is amended to reflect one (1) additional hutch, 66", located in 105E along back wall (GoCUID 1bHHCLS15L66XBPXXKX)


