A. PROVIDE ANSWERS TO QUESTIONS RECEIVED

Question 11: Given the remote nature location of the site, and the duration of the contract, it is impractical to identify full-time, on-site resources who will solely deliver work within the scope of their role for up to five years. We would instead propose to have qualified back-ups available to cover vacation, illness, or rotational shifts. The language in Section 5.2.1 of the RFP related to Status and Availability of Resources, and 2035 08 (2008-05-12 Replacement of Specific Individuals) is restrictive and does not permit substitutions for reasons other than death, sickness, parental leave, retirement, resignation, or dismissal for cause. Would Canada consider allowing for the use of similarly qualified back-up staff following contract award to provide support to the identified on-Site personnel to allow for vacation coverage, the provision for staff rotations, and to replace staff occasionally for their mental well being over the and up to 5-year contract term?

Answer 11:

Please refer to addendum 2 to the solicitation below.

Back-up personnel may be substituted for the Key Team Members proposed on the Annex H - Team Identification Form. These substituted personnel will be required to meet the criteria specified in Annex A – Statement of Work (Appendix 6). These back-up personnel will be for temporary situations for leave coverage (vacation, sick leave, medical leave etc.).

At this time, Canada is not considering regular staff rotations.

Question 21: We would like to request a two week extension for Solicitation No. EZ897-220593/A, Faro Mine Environmental Monitoring Services, which currently closes on January 12, 2022.

Answer 21:

The previous solicitation amendment 001 was issued to extend the solicitation closing date from January 12, 2022 at 14:00 PST to January 26, 2022 at 14:00 PST.

Question 22: The RFP requires constant laboratory operation, while specifying one (1) Lab Manager / Lead Chemist.

- a. Is the Lab Manager/Lead Chemist expected to be at the laboratory full time, requiring residence in Faro?
- b. Would a 2 week on-site/2-week off-site position supported by lab technicians be acceptable?

Answer 22:

- a. Yes, a Lab Manager / Lead Chemist is expected to be onsite at the laboratory full time (~35-40 hours per week).
- b. No, the lab manager is required at site full-time.

Question 23: For full time-onsite staffing, are the MCM camp facilities available for full time on-site staff for this contract? Specifically, what accommodations/facilities (including laboratory storage and office space) are available at site for full time staff. Is the MCM staff facilities/cafeteria available for use, and if so, is there a charge for this use?

Answer 23:

There will be a period of time in the near future (for example, after October 31, 2022) when there will be no camp and no cafeteria available as they are both located on the footprint of the future Permanent Water Treatment Plant. Therefore, the camp and cafeteria will need to be relocated before the construction begins of the new Permanent Water Treatment Plant.

The current MCM work camp might still be in use until October 31 2022. If available, the work camp could be used for the EMS staff. Currently the cost per day per person for camp including meals is \$250 CAD. The current service provider – Outland – will accommodate use of the cafeteria for meals only. It is \$21 per meal and it is the same price for breakfast, lunch and dinner.

Question 24: The RFP notes that part time staff may be required to travel to site as needed. Will travel time/incidentals/hotel costs be covered for these individuals to come to Faro?

Answer 24:

Yes, for all positions categorized as "On or Off site (Full time & Part Time)" as per Table 3 in Annex A, Section 8.2, the Contractor will be reimbursed for the authorized travel and living expenses reasonably and properly incurred in the performance of the Work, at cost, without markup, in accordance with the meal and vehicle specified in Appendices B, C and D of the National Joint Council Travel Directive. Please refer to Annex B – Basis of Payment, Section B3 Travel Expenses for further information.

Question 25: Given the remote nature of the project, the term, and the ongoing COVID-19 challenges/restrictions is there flexibility around staff substitutions provided the employee skills and experience are equivalent or better than those outlined in the RFP document?

Answer 25:

Yes, substitution of staff will be permitted for reasons considered beyond the control of the Contractor, as per GC 2035 08 Replacement of Specific Individuals, provided the replacement provides equivalent or better qualifications and experience, meets the criteria used in the selection of the Contractor, and is acceptable to Canada. Substitutions must be pre-approved by the Contracting Authority. See also Question and Answer 11.

Question 26: The RFP notes that "Some positions may require additional staff on a seasonal basis." Staff for seasonal work is generally more expensive than known full time/part time staff. Will PSPC allow a seasonal adjustment on provided rates for these additional seasonal staff?

Answer 26:

No, the hourly rate for each position will be the same regardless of seasonality or length of task.

B. INCORPORATE ADDENDUM 002

1) AMEND Part 8 – 8.2 Team Composition Notes

ADD: 8.2 Team Composition Notes:

- .6 Back-up personnel may be substituted for Key Team Members proposed on the Annex H – Team Identification Form. Substituted personnel will be required to meet the criteria specified in Annex A – Statement of Work (Appendix 6). These back-up personnel are for temporary situations for leave coverage (vacation, sick leave, medical leave, etc.).
- .7 Contractor will be required to identify back-up personnel as necessary either at the issuance of a TA or at any time throughout the execution of the work.
