ELEVATIONS, SECTIONS

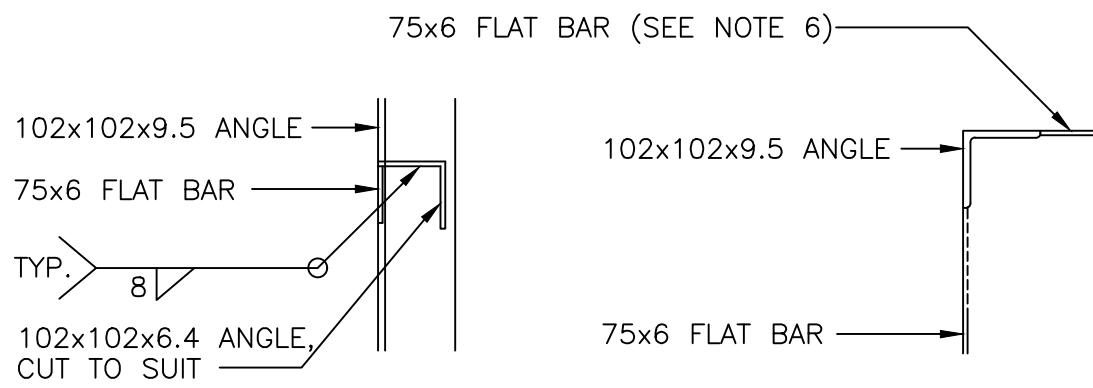

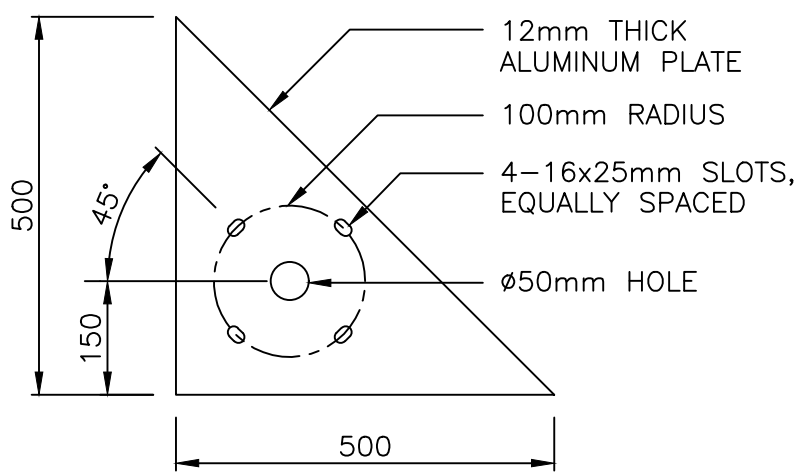
ANGLE BRACKET

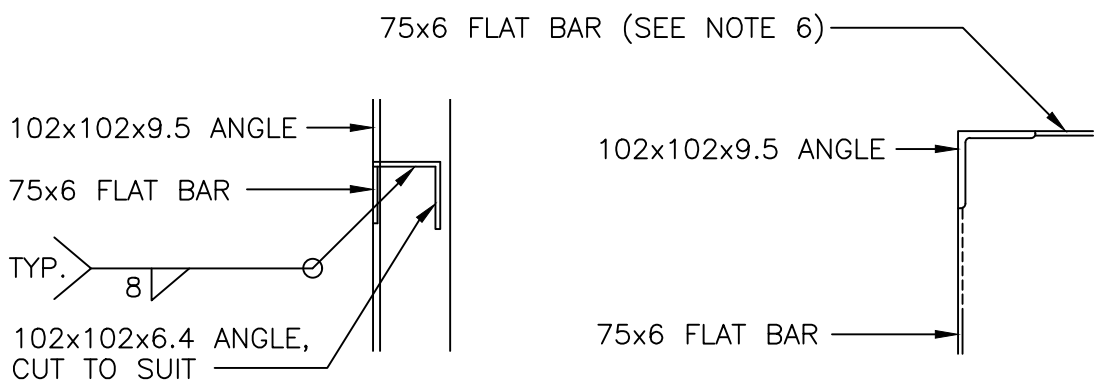
BASE PLATE DETAIL 3

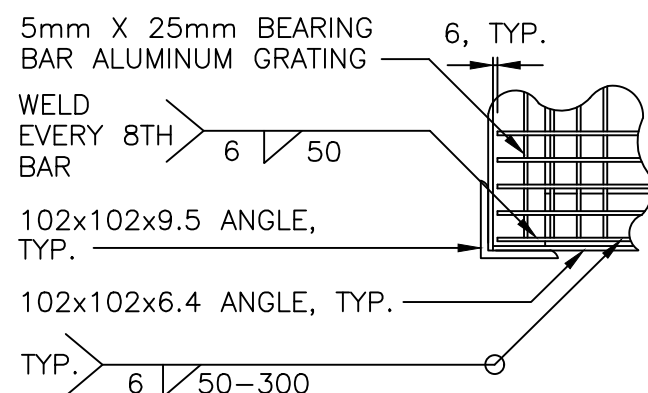
LADDER DETAILS
