The Department of National Defence (DND) 31 Canadian Brigade Group has a requirement for the supply and delivery of music equipment in support of multiple professional military bands in the Southwestern Ontario area.

1.2 Background

Due to the professional nature of these bands and their importance to unit history and heritage all instruments must be of professional caliber and suitable for parade, concert and small ensemble work. The instruments supplied must be brand new and come with a manufacturer warranty.

Q2. - Re 2.2.2.17, Which MacGregor tartan?

A2. - The MacGregor tartan as associated with the Essex and Kent Regiment.

Q3. - Re 2.2.2.18, do they want small for the covers or do they mean extended small?

A3. - See Revised Annexes.

Q4. - Re 2.2.2.8 , 2.2.2.9, 2.2.2.10, and 2.2.2.11, is described as complete with pipe bag, cover, cords and reeds and ready to play. Is this correct?

A4. - Yes, a complete ready to play set is required.

Q5. - Are partial bids acceptable?

A5. - Yes.

Q6. - Should the cost of shipping from here (Vancouver Island) to London Ontario be separate or included?
