1.0 QUESTIONS AND ANSWERS

- Q1. The floor plan does not show the 30x72 benching.
- A1. The floor plan includes the 30x72 benching. Please refer to the AutoCAD floor plan for more details and note that the CRA indicated the proper required product code in Category 2, Table 1.
- Q2. Category 2, item 3, code 2B3LREXXL30L60BELFR refers to benching with 3 long surfaces facing each other. However, in the plan, there is only one face to face and two single side, please clarify.
- R2. Code 2B3LREXXL30L60BELFR is the correct product required by the CRA.
- Q3. Category 3, item1,

1) The code refers to 12 " wide x 18 " deep lockers, but in the plan they are 15 " deep. In addition, the quantity in plan is 40 and not 60. Please specify.

- 2) Do you want a shelf at the top of the locker room?
- 3) Do you want a full width hanger bar or brackets?

R3.

1) The CRA requires products of code 3LSL1HXXLM12D18XHXK and the exact quantity is 60.

2) No.

- 3) The CRA will accept brackets.
- Q4. Category 6, item 6 (6STCWLXXLUXXXXXNNX), can you confirm that the code referring to the left side for the tablet arm is correct?
- R4. Code 6STCWLXXLUXXXXXNNX is the correct product code required by the CRA.
- Q5. Category2,
 - 1) Where does the electricity and data come from: from the floor or from the ceiling?
 - 2) How many duplexes per station?
 - 3) Can privacy screens be fabric?
 - 4) Do you want a screen on each table or one in the middle between the two tables?

R5.

- 1) They come from the ceiling via electric columns.
- 2) A minimum of two (2) double duplexes per station.
- 3) No, they cannot be fabric. They must be glass frosted as required by code.
- 4) Benching must include partitions for privacy between users. See amendment to the RFB.
- Q6. Category 1B (1bCFHLX24L42XBFFFKX), can you confirm exactly that the CRA requires credenzas?
- R6. Yes, CRA requires credenzas as indicated by code 1bCFHLX24L42XBFFFKX.
- Q7. For Category 2, items 2 & 4 only include a central glass divider. Agree?
- R7. Yes.

- Q8. Category 2, item 3, please confirm that a series of tables should only have 5 surfaces in total to make room for the obstruction indicated?
- R8. Yes, the CRA confirms.
- Q9. Category 6, item 2 (6SBATWXXBUW3G19LMYN), will the CRA accept products with legs?

R9. Yes.

Q10. Category 6, item 4 (6SMORBXXLU25G19LYNN),

1) Is the desire to have each unit with a back?

2) There are two units in the middle, should these be accessible from each side, so no back?

3) Please advise if the requirement is for a backless unit to connect from both sides, i.e. a 90-degree corner unit with back?
