B. QUESTIONS & ANSWERS

Q7: Item 1. (a) states "black" colour. Could you please clarify if requirement black colour is dope/yarn dyed or fabric dyed.

A7: Fabric dyed is accepted.

Q8: Item A.3 "Deliverables" states "Estimated" Annual Quantities rather than "Firm" Annual Quantities. We wanted to clarify if there would be a requirement for this fabric in the initial period as in the past we were not issued a call-up in the initial period for certain fabric RFSO's we were awarded.

A8: No firm quantities.

Q9: Due to the nature of the product, Could you please advise if $\pm 6\%$ tolerance on unit mass of fabric is acceptable ?

A9: Please follow the requirements as defined in the solicitation documents.

Q10: I understand this will be for blanket manufacturing, however what purpose will these blankets be used for?

A10: Blankets for sleeping

Q11: Are you open to the product being non-washable ?

A11: Yes

Q12: Will the blankets that will be produced with the requested fabric be the (suicide revention) or (Anti-Suicide) blankets ?

A12: No
