Amendment 002 is raised to answer bidder questions and modify the tender document as follows:

Question 1. May we deliver a machine which contains some used components which we would replace with new components after initial delivery? Given current lead times from some of our key suppliers and the required delivery date to CFB Trenton of 31 Mar 2022 it is impossible for us to provide a machine which is composed 100% of new/never used components. (We haven't seen any written requirement that the hardware be new. Is there such a requirement in the Standard Clauses or Instructions?)

Response 1. This would be acceptable, provided the machine is fully functional, and that the used components are replaced with new components as soon as they are available from the manufacturer. New parts are referenced in the repair procedures section. We would also hold to the baseline (3.1) requirements as if the initial delivery was made with all new parts.

Question 2. UPS requirement: Our standard UPS keeps the machine on standby (maintaining position data, etc.) for up to 20 minutes in the event of a power outage. It is not, however, intended to support active printing (extruder movement, heating, etc.). We believe this meets the requirement in solicitation section 2.2.4.b but want to be sure.

Response 2. This is acceptable. The requirement is to ensure a print does not need to be restarted from the beginning due to a short interruption in power.

Question 3. Sec. 2.0 of Annex A Part 1 has three locations with the text, "Error. Reference source not found". What are the missing references and are they important?

Response 3. These are slight typos, and should read as follows:

- b. A Technical Data Package (TDP) in accordance with Section 2.2, within two months of Contract Award or prior to the first delivery, whichever is first;
- f. Product Support in accordance with Section 3.2.
- Optional procurements are described in Appendix 1.

Question 4. How do we obtain a copy of D-01-100-214/SF-000 Specification for Preparation of Provisioning Documentation for Canadian Forces Equipment?

Question 5. Visa and MasterCard purchasing cards are listed as payment options we must be willing to accept. May we propose and if awarded the contract include a clause that adds a fee in the event a purchasing card is used?

Response 5. It is your option on what method of electronic payment you will accept. Canada will not pay fees to use Visa or MasterCard for payment.

Question 6. The only security requirement we see is for "Reliability Status" for supplier personnel. From what we can tell, this simply involves submitting the names and other details of any supplier employees who will be entering DND buildings for review prior to any visit. Is this correct? If not, can you explain or may we contact the individuals listed as authorities in the SCRL which is part of the solicitation package?

Response 6. The bidder and their personnel who require access to DND operational areas must have a Reliability Status security clearance. That will involve organizational and personnel screening by the PSPC security division. More information is available at [Security requirements for contracting with the Government of Canada – Canada.ca \(tpsgc-pwgsc.gc.ca\)](https://www.tpsgc-pwgsc.gc.ca). This security screening process can take many months to complete.
