2. Request for Proposal, A9. Site Visit:

DELETE:

“It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at 46 Hanover House, London, United Kingdom (UK) on **January 13, 2022**. The site visit will begin at 13:00 (local time in London, UK.).

Bidders are requested to communicate with the Contracting Authority no later than three (3) business days to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders may be requested to sign an attendance sheet. Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a proposal.

Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.”

Bidders are requested to communicate with the Contracting Authority no later than three (3) business days to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders may be requested to sign an attendance sheet. Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a proposal.

3. Request for Proposal, A12. Bidder’s Conference:
