**Solicitation Amendment 002 is raised to answer the following bidder questions.**

**Q1. Does the end-user want an SPR or ITC system? The specifications are open and general, and both types of instruments could potentially meet the requirements.**

A1. We prefer the SPR system, since ITC platforms are limited to affinity determination and will not measure real time binding kinetic (Kon and Koff). Additionally, the ITC system usually needs a large sample quantity (Reference: Annex A, 4.0 Mandatory Technical Requirements)

**Q2. Do you require any type of sensor such as glass sensor, metal sensor, inorganic sensor, etc? If yes, how many of each type do you need?**

A2. Any sensor which meets the mandatory technical criteria at Annex A, 4.0, paragraphs 1 (a), (b), (c) and (d) is acceptable. The bidder must include enough sensors for training as required under Annex A, section 2.3.

**Q3. As a result of the impact that COVID-19 has been having, would you be able to accept virtual on-line installation and training or allow us to schedule on-site installation and training after March 31, 2022.**

A3. To accommodate this request, we are changing the installation and training requirements as follows:

(a) Training must be delivered virtually, online by March 15, 2022.

(b) Installation will no longer be a mandatory requirement of the initial contract and may instead be purchased as an option.

The solicitation document is thereby changed as follows:

1. At Part 6, paragraph 6.2, insert:

**“6.2.1 Optional Requirement**

(a) The Contractor grants to Canada the irrevocable option to acquire installation as further described in Annex “A” under the same terms and conditions and at the prices and/or rates stated in the Contract. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

(b) The Contracting Authority may exercise the option at any time before the expiry of the Contract by sending a written notice to the Contractor.

2. Delete Part 6, paragraph 6.6.1 in its entirety and insert:

**“6.6.1 Basis of Payment**

1. Initial Requirement

In consideration of the Contractor satisfactorily completing all of its obligations under the Contract, the Contractor will be paid a firm price, as specified in Annex “C”, Table C-1, for a cost of \$ (to be completed at

contract award). Customs duties are included and Applicable Taxes are extra.

2. Optional Requirements

For the option to purchase Installation, Canada will pay the Contractor firm unit price(s), as specified in Annex "C", Basis of Payment, Table C-2. Customs duties are included and Applicable Taxes are extra.

3. Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work unless they have been approved, in writing, by the Contracting Authority before their incorporation into the Work."

3. Delete Part 6, paragraph 6.6.2 in its entirety and insert:

**"6.6.2 Multiple Payments**

4. At Annex "A", 2.0, delete paragraph (b).

5. Delete Annex "A", 2.2 and 2.3 in its entirety and insert:

**"2.2 Online Training**

The Contractor must provide a one (1) day course for a maximum of two (2) technicians and one (1) research scientist in English.

Training must be delivered virtually, online at a time mutually acceptable to both the Technical Authority and the Contractor.

At a minimum, the training must include the following topics:

- (a) Procedure for connecting the instrument to a PC;
- (b) Operation; and
- (c) Data Analysis.

All consumables necessary for the training must be included with the delivery of the Benchtop Label-free Binding Kinetics and Affinity System.

All costs associated with training must be included in the price at Annex "C", Table C-1, item 2.

6. Delete Annex "C", Table C-1 in its entirety and insert:
