The following changes, additions and/or deletions are hereby made a part of the Contract Documents for ***Mission Medium Institution Watermain Replacement PWGSC Project No. R.089147.001 Pacific***, as fully and completely as if the same were fully set forth therein:

Note to Tenderer's

1. Specifications 33 11 16 Part 2.3 and Part 3.5.21 to be disregarded. Tracer wire NOT to be installed.
2. Existing Domestic and Fire Watermain operating pressure fluctuates between 90 – 135 psi.
3. All existing paved and landscaped surfaces, concrete ramps, stairs and any other element disturbed during construction should be restored after completion to match existing conditions or better. Limits of works will be determined by contractor method of construction. Also, any temporary works for construction access will be determined at time of construction following Contract Administrator & Public Works review and approval.
