1. Respond to bidder questions

Part 1 General

- .1 This addendum is to be read with and constitutes part of the tender document.
- .2 Amend your copy of the tender/quotation/proposal in accordance with the detail below.

1.2 ADDENDUM ITEMS

- .1 Dual head capstan further clarifications
 - .1 Refer to addendum No. 4 for further details.
 - .2 Dual head capstan will remain, can investigate single head option once tender is closed.
- .2 Foot pedal switch operation clarification
 - .1 The foot pedal is to be an ON/OFF switch only (assuming the operator sets the speed independently at the VFD panel.
 - .2 Foot pedal is to be non-reversing and the system is one-direction only.
- .3 General commissioning requirements clarifications
 - .1 The Department Representative is not responsible for appointing and costs related to CxA as written in Section 01 91 13 Sub-section 1.8.1 of the specifications. This shall be the general contractor's responsibility.
 - .2 The knowledge of the operation and setup is indicative of the manufacturing/supplier.
 - .1 Operation intent and performance requirements are outlined within the contract documents.
 - .3 Verification, training, and performance verification of the capstan can be done by the manufacturer's technical representative. They will not be responsible for other interface equipment in the pit, i.e., HVAC.
 - .4 Time limits and or minimums can be placed for the training/ performance.
 - .1 Minimums for training sessions are typical, around 3hr per session and to cover each section of the O&M Manuals. Performance verification should cover all aspects of the Owner's Project Requirements and the basis of design in accordance with the contract documents. Training can also overlap with performance verification in situations where simulations are costly or difficult to repeat.
 - .5 CxA knowledge and abilities can have an impact on costing, allowance for adjustments due to unknowns appointed by others will be handled as below.
 - .1 The CxA's responsibilities are outlined in Part 2, Section 2.1, along with the responsibilities of other parties involved in commissioning. Allowances for adjustments is at the bidding contractor's discretion.

- .6 Section 01 91 13 Sub section 2.4.1; General Contractor sub section “Appoint Commissioning Authority” clarification.
 - .1 The General Contractor is to appoint the commissioning authority to ensure acceptable representation, with the means and authority to prepare and coordinate execution of the commissioning program as described in the contract documents.
- .7 Capstan manufacturer acceptable for CxA
 - .1 The Capstan manufacturer should contribute to the overall responsibilities listed under General Contractor but could refuse to take on certain responsibilities (such as the overall construction schedule and building permits). The General Contractor should have an appointee with the appropriate agency to execute the entire commissioning program.
