1) Question and Answers

Q1) ABES Submission Document

Amendment 4 requests we delete SI06 Submission of Bid in it's entirety and replace with SI06 Submission of Bid provided in Amendment 004. As this section forms part of the Invitation to Tender to be submitted, can the original SI06 be stricken out and initialed and labelled "SUPERSEDED" and the new SI06 inserted and initialed or please confirm how PWGSC would like us to replace the revised section in the tender form.

A1) Solicitation Amendment 004 was raised to delete and insert a revised Special Instructions to Bidder at SI06 Submission of Bid. The original SI06 does not need to be "stricken out" as solicitation amendments, by its definition, will supersede the preceding sections that it replaces. If required, PWGSC will ask the bidder to sign the cover page of the Solicitation Amendment to acknowledge and accept the amendment.

It is important that bidders are reminded that the only means of submitting a bid is electronically using the Canada Post epost Connect application. Faxed and hard copy (submitted in person or via mail/courier) bids will not be accepted for the subject bid solicitation.

Q2) Revised Bid and Acceptance Form

Please confirm the correct Bid and Acceptance Form has December 31, 2022 for the completion date in BA06 Construction Time.

A2) The correct bid and acceptance form to be submitted with the bid package is found at page 13 of 21 in the Invitation to Tender dated December 30, 2021. The form has a completion date of December 31, 2022.
