Solicitation amendment #004 is raised to provide the following questions and answers:

Q4: If we bid on 1a) and are unsuccessful, is there consideration for 2a)

- a. To clarify, would we be able to bid on both 1a) and 2a)? However, only be awarded one or the other?

A4: Yes, a Bidder can submit a bid for both items 1a and 2a. Up to two contracts will be awarded for item 1a and only one contract will be awarded for item 2a. If a responsive Bidder is one of the two lowest evaluated prices for item 1a and is the lowest evaluated price for item 2a, it would be recommended for award for both items. Bidders may be recommended for award for multiple items in accordance with 1.11 Basis of Selection.

Q5: What is the date that you are expecting to award the contracts?

A5: Contracts are expected to be awarded by mid-February.
