Question 7: Part 4 – 2.1.1.2 sub para 2 supporting Technical Documentation sub sub para (b) test report(s) ii states that test reports must be dated within 12 months of the solicitation posting date. Would the government consider removing this requirement?

Answer 7: The Government will not remove the date requirement but will agree to extend it to within five (5) years of the solicitation posting. If a product was certified prior to this time frame, more recent testing is required to ensure that the product continues to meet its initial performance ratings.

Question 8: What is the estimated quantity/value of the National Master Standing Offer (NMSO)?

Answer 8: The estimated usage cannot be provided as multiple Departments will have access to the NMSO.
