QUESTION AND ANSWER – SERIES I

Q1. What do interested Respondents/Supplier need to submit and the dates of submission?

A1. Suppliers interested in participating in the Industry Day scheduled for February 28, 2022 must confirm their attendance by providing, in writing, to the Contracting Authority, the name(s) of the person(s) who will be attending and their title, the invitation form and a list of potential concerns they wish to discuss no later than February 11, 2022.

Responses to the following must be submitted only by facsimile or epost Connect to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by 2:00 p.m. EST, January 28, 2022.

1. Annex A – Preliminary System Requirements;
2. Annex B – Additional Industry Capability;
3. Annex C – Procurement and ITB/VP Questions; and
4. Appendix A to Annex A – Camp Sustain Costing Matrix.

Q2. What are the differences between the closing date of March 31, 2022 and submission dates of January 28, 2022 and February 11, 2022?

A2. The Request for Information (Letter of Interest) solicitation closing date is currently March 31, 2022. January 28, 2022 is the submission date for responses to specific questions and information requested as per above response in A1. Meanwhile, February 11, 2022 is the deadline date for confirmation of attendance to the Industry Day, as per above response in A1.

Q3. The RFI(LOI) indicated that the international trade agreements apply yet it also indicates that the ITB Policy may apply. Please advise and confirm which applies.

A3. Currently, the trade agreements apply to the requirements identified in the RFI(LOI). However, following industry engagements (Industry Day(s), one-on-one sessions, etc.) and internal consultations may determine that the ITB Policy applies. Changes will be made to the requirement through the RFI (LOI) whether the Trade Agreements or ITB Policy applies once this is determined.

Q4. When will you be supplying Appendix A to Annex A – Costing Matrix?

A4. Appendix A to Annex A – Camp Sustain Costing Matrix was added to the Deployable Camp Infrastructure and Utilities Systems (Camp Sustain) (W8476-226540/A) RFI (LOI) solicitation on December 22, 2021. Please refer to the Notice attachments.

Q5. Is it possible to send you the registration details directly, or do I need to go through the epost Connect conversation protocol?

A5. Suppliers interested in attending the Industry Day and One-on-one sessions are requested to confirm their attendance by providing, in writing, to the Contracting Authority, the name(s) of the person(s) who will be attending and their title, the invitation form at Annex D, and a list of potential concerns they wish to discuss no later than February 11, 2022. Suppliers do not need to go through epost Connect.

As per A1 above, responses to the following must be submitted only by facsimile or e-post to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by 2:00 p.m. EST, January 28, 2022.
