The propose of this project is to define the work to be performed by the contractor for an in-depth cyber Vulnerability Assessment/Penetration Test (VA/PT) to be conducted on the RADARSAT Constellation Mission (RCM) Ground Segment system installed at CSA St-Hubert, CSA David-Florida Labs and at the Canadian Data Production Facility (CDPF) in Gatineau.
